Purpose of the post

The work:

The role will include prioritising and promoting health and wellbeing in community settings by taking an informal and personal approach to working with communities to support and address their priorities in relation to mental health and aid the delivery of mental health support in areas of most need by

- Using informal networks, local connections and knowledge to reach people and their families who are suffering with mental ill health, this could be in workplaces, communities, neighbourhoods and local social hubs
- Having motivational and strengths-based conversations
- Linking with existing community groups and organisations who are already embedded in the heart of the communities, leaving a legacy through them
- Increasing capability, opportunity and motivation, to self-motivate to increase community participation which supports Doncaster's mental health transformation programme
- Helping others to access support
- Promoting equity in health by working in partnership with individuals and groups that face barriers to good health.
- Acting as an ambassador and represent Doncaster Mind at external functions, events to a maximum of four per year.

- Being familiar with the Doncaster Mind 'Code of Conduct' and ensure that it is followed at all times both by staff, volunteers and clients.
- Participating in supervision and internal/external staff development including mandatory training related to the role.
- Taking responsibility, with colleagues, for ensuring that all Health and Safety, Safeguarding, Information Gathering and Equality & Diversity requirements are met and all other Company policies complied with.
- Attending and contributing to regular team meetings.
- Ensuring understanding of and compliance with all Doncaster Mind's policies and procedures.
- Working in alignment with the aims, objectives, and core values of Doncaster Mind.
- Undertaking any other duties that may from time to time be reasonably required.
